Subject: Decision on appeal against granting further accreditation to Post Graduate Diploma in Management program for a period of 3 years instead of for 6 years offered by Jaipuria Institute of Management, Vineet Khand, Gomti Nagar, Lucknow- 226 010, Uttar Pradesh.

Sir,

This has reference to Appeal dated 03-11-2019 filed by Jaipuria Institute of Management, Vineet Khand, Gomti Nagar, Lucknow- 226 010, Uttar Pradesh against the decision of NBA granting further accreditation to their Post Graduate Diploma in Management program for a period of 3 years instead of for 6 years, communicated vide NBA's letter of even number dated 15-10-2019.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 23-12-2019. The recommendation of the Appellate Committee was considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the Post Graduate Diploma in Management program, in suppression of NBA's letter of even number dated 15/10/2019, is given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Jaipuria Institute of Management, Vineet Khand, Gomti Nagar, Lucknow- 226 010, Uttar Pradesh as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

5. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

6. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
