



## Admission Policy PGDM-SM 2024-26

### ELIGIBILITY

Graduation with minimum qualifying marks as per AICTE norms or equivalent CGPA in any discipline from a university recognized by Association of Indian Universities / AICTE. Candidates appearing in the final year exam of graduation in 2024 are also eligible to apply. However, in case they are admitted, they will have to submit result of their graduation exam by notified date. The admission will stand cancelled in case they do not obtain minimum qualifying marks in graduation.

### SUBMISSION

**Online:** Application Form can be filled and submitted online on our website along with online payment of the application fee of Rs. 1000/-.

### VENUES

Selection process will be conducted at Agra, Ahmedabad, Allahabad, Amritsar, Bhopal, Bilaspur, Bhubaneswar, Chandigarh, Dehradun, Gorakhpur, Guwahati, Gwalior, Indore, Jamshedpur, Jabalpur, Jaipur, Kanpur, Kolkata, Lucknow, Noida, Patna, Raipur, Ranchi and Varanasi. All the above mentioned locations are tentative. The Institute reserves the right to cancel any of the above outstation centres. Centre for CAPI may be chosen according to your convenience, candidates will be informed about the date and venue.

### SELECTION

The selection to the Post Graduate Diploma in Management programme is purely based on cumulative performance of the candidate which comprises management entrance score (CAT 2023/XAT/CMAT/MAT/ATMA/GMAT/CUET) followed by case analysis and personal interview. The objective is to identify and assess interpersonal skills in addition to the overall knowledge of the student. Due weightage are given to past academic achievements and work experience, apart from the above mentioned parameters.
